-how will budget affect funding for students? Peter

- -cuts by attrition has well placed McGill
- -GEF money, handed out haphazardly to departments, should remain intact and has been kept for 2015-2016
- -grad funds for students working in other labs has been cut
- -GREAT will continue for 2015-2016
- -why more hires, in light of cuts? Andrew
  - -McGill believes in profs instead of contract academics
  - -8 new hires, unknown number of faculty exiting

Jonathan Mooney & Nikki Meadows, PGSS Financial Affairs Officer -in 2012, MCGSS being charged by PGSS & MCSS, but not getting real benefits of either

- -MCGSS terminated its membership in MCSS and pursued an agreement with MCSS to retain used services to be paid by PGSS (~5000\$/year) and MCSS turn over ~300 000\$ by grads for the new building fund
- -this sum is an approximate calculation of fees that grad students had paid over 20 years toward grad student space in any new building at Mac
- -MCSS did not sign the final agreement, and as a result, PGSS has not paid a cent to MCSS, but a letter of understanding, which committed

- MCSS to finalise the contract, including when PGSS pays etc.. and the ~300 000\$, our current President and Vice-President, Peter and Nic, respectively, signed on behalf of MCSS
- -June 1<sup>st</sup>, 2012, MCSS refused contract, no services, no recognition of the original vote to terminate MCGSS membership in MCSS, so a second vote was held, upholding 1<sup>st</sup> referendum, and our membership was terminated
- -by Feb. 2013, have really only established MCGSS are not members of MCSS, and haven't resolved anything else since
- -in Feb. 2015, our lawyer's letter, encouraged MCSS executives to meet with us, and now have a meeting April 8th, 10am, where Maeghan and Niki will meet with the MCSS President, VP-Finance, and Lise
- -note that in light of any conflict of interest, Peter remained out of the room for this discussion and council's subsequent discussion on how to proceed (see below, Building Maintenance Fund)

  - -council agrees that unless grad students have physical possession, it is not possible to guarantee that the Building Maintenance Fund will be spent on securing grad student space; council agrees to seek full ownership over the Building Maintenance Fund
