

AGREEMENT BETWEEN:

Post-Graduate Students' Society of McGill University, Inc. at 3650 McTavish, Montreal, Qc., H3A 1Y2, Represented by Dhanesh Patel (hereinafter referred to as "PGSS)

AND:

Macdonald Campus Graduate Students' Society Represented by Jasmine Muszik (hereinafter referred to as "MCGSS")

Collectively "the Parties"

1. PREAMBLE

Whereas the Macdonald Campus Graduate Students' Society represents PGSS members enrolled in programs at Macdonald Campus.

Whereas all PGSS members pay \$40.95 per term for the "PGSS Regular Membership Fee", which is used to "provide activities, events and services to its members".

Whereas the PGSS primarily operates on McGill's downtown campus, resulting in some MCGSS members having limited access to the operations of the PGSS.

Whereas on April 30, 2018, the PGSS and MCGSS entered into an agreement under which the PGSS agreed to return a portion of the "PGSS Regular Membership Fee" collected by the PGSS to the MCGSS to allow them to provide additional activities, events and services to their membership on the Macdonald Campus.

Whereas the Parties undertook to discuss the extension of this agreement for one year (ending in May 2024);

Whereas the Parties undertook to discuss a renewal of this agreement for 5-years (ending in May 2029).

2. AGREEMENT

THE PARTIES THEREFORE AGREE AS FOLLOWS:

- 2.1. The PGSS agrees to return to the MCGSS the following amounts per member per term (Fall and Winter) out of the PGSS Regular Membership Fee:

- 2.1.1. For the Fall 2024 term and the Winter 2025 term: \$6.33 plus Consumer Price Index (hereafter referred to as CPI) of the previous year, as set McGill (same calculation they use for PGSS membership fees collected each term, usually twelve-month trailing average of the CPI). For example, payments for Fall 2024 will be $\$6.33 + 3.59\%$, or $\$6.56$, and Winter 2025 will be $\$6.56$. For Fall 2025 and Winter 2026, the fees will be $\$6.56 + \text{CPI}$ (of that year) for each term.
- 2.2. Every Fall and Winter term, the MCGSS will receive the amounts by direct transfer, based on MCGSS enrollment numbers by 31 October for the Fall terms and 15 March for Winter terms of that given year.
- 2.3. MCGSS shall provide a detailed summary report describing the services provided by MCGSS to PGSS members with the funds received during the previous term.
- 2.4. MCGSS will receive a one-time payment from PGSS to the amount of \$2,081.51 for errors made by MCGSS during invoicing in the 2019-2021 years.
- 2.5. In the event of disaffiliation of the MCGSS from the PGSS during the term of this Agreement, the MCGSS will reimburse the full amounts transferred in accordance with Section 2.1 for the current term and will not be entitled to future payments.
- 2.6. MCGSS shall be consulted during the process of negotiation of a new Memorandum of Agreement between the PGSS and Macdonald Campus Students' Society (MCSS).
- 2.7. This agreement shall expire on May 31, 2029.
- 2.8. The Parties undertake to come together in good faith before the end of May 2029 to discuss the extension of this Agreement to future years.

3. APPLICABLE LAW

- 3.1. The Agreement shall be governed by and construed in accordance with the laws of the Province of Québec.

4. LANGUAGE

- 4.1. This Agreement has been written in English at the request of the Parties. La présente Entente a été rédigée en anglais à la demande des Parties.
